## **Inspection of New Haw Community Junior School by Ofsted**

We have just told your child's school that we will inspect it on 02 February 2023. The lead inspector will be Maria Roberts, HMI. To register your views, you will need to provide your email address, which will be held securely. It will not be used for any purpose other than providing access to the online survey. Neither schools nor Ofsted will have access to any email addresses.

Please complete the online survey by **11am** on 02 February 2023 as this will give the inspection team more time to consider your views. However, we will consider all online responses that are completed during the inspection, although the free-text box facility will not be available after noon on 03 February 2023.
